From the President's Desk

Happy Anniversary **KDO**!
On June 06, 2023, **King's Daughters** celebrated 130 years of supporting **Seniors in Sangamon County**. It's truly amazing that 130 years after its formation, one woman's wish to break barriers between the rich and the poor would have evolved into this incredible organization. As those women from the past look down upon us today, I think they



would be pleased. Maybe we are not doing exactly what was imagined, but the intended purpose lives strong.

The **Annual Corporation Meeting** was held on May 22, 2023, at **Westminster Presbyterian Church**. It was an exciting day celebrating our 2023 grant recipients and reflecting on **KDO** accomplishments over the last year.

Awarding a total of \$255,000 ... the greatest single year amount awarded in **KDO** history ... to sixteen non-profit organizations in **Sangamon County**, was definitely the highlight! It might be hard to believe, but COVID actually contributed to this success. Due to enhanced budgets during and after COVID, frugal spending, and the huge success of the 74th Annual Luncheon and Style Show, the **KDO Board of Directors** was able to approve a "pass through" of an additional \$45,000 from **KDO** to the **Community Foundation for** the Land of Lincoln to supplement its original \$180,000 grant allocation from KDO's Donor Advised Fund. KDO had received the largest request for funding to date, over \$450,000 from 33 applicants. The approval of these additional funds, will definitely help the recipient organizations recover.

Re-engagement of our membership remains a priority. "Getting back together again" resonated loudly in every event that transpired over the last year. It is and was important to allow for some "self care" ... to bring people back together and hopefully enhance our membership. **KDO** had three social events throughout the last year. Members were encouraged to bring guests to each of these functions. As a result of these

efforts, 42 new members have been added to our roster! We plan on continuing these types of events throughout this next year with hopes for generating even more interest in **KDO**!

Community Awareness will remain a priority for 2023 and 2024. Articles about **KDO** were published several times, trying to keep us from being the "best kept secret in Springfield." Our new brochure is almost ready, and we are hoping to roll out a new and enhanced web page very soon. All of these efforts will definitely help our exposure.

There are so many things to look forward to in the upcoming year, including **KDO Socials**, Activities at the **IPH**, delivery of **Daily Bread**, field trips to grantee facilities, grant committees and of course the **75th Annual Luncheon and Style Show**. We have our running shoes on and ready to take on the Marathon ... stay tuned.

Traditional and Blackstock Grants



After 130 years, it finally happened ... again! We made HISTORY!! It was a milestone year where for the first time our accumulated grant funding of \$2,200,000 surpassed our original deposit to our **CFLL-Donor Advised Fund**.

Yet, there were many other firsts for this grant cycle. It started with contacting the most potential candidates ever. The **Community Foundation for the Land of Lincoln** (CFLL) went above and beyond by finding additional avenues of resources that touch the senior population. We

held our very first Grant Information session at **Innovate Springfield** to let applicants know the criteria, priorities, and **KDO** history, as told by Past President **Brenda Staab** (MB). It became our most competitive year when we received 33 applications -- the highest number in a single year to date.

Many of the requests were upwards of \$25,000. This resulted in the highest combined request of \$451,286 for **Traditional Grants** alone. With this year's allocated Traditional Grant amount totaling \$180,000, it quickly became evident that this cycle could be challenging and interesting to see unfold. Because of the great influx, the committee made the decision to strictly consider awards based on aligning to our mission. To our benefit, we were able to receive an additional \$45,000 "pass through" for the **Traditional Grant** allowing us to award the most money to date, \$255,000, including \$30,000 of **Blackstock Grant** funding, to 16 non-profits in **Sangamon County**.

Thank you to the Traditional and Blackstock Committee members for their dedication and hard work. (Please see Page 7 for **Blackstock Grant** details.)





KDO BLACKSTOCK GRANT

The general purpose of the **Blackstock Grant** is to do something proactive for the unmet needs of the seniors in Sangamon County. To get a better feel for what is currently most at stake, KDO President Kim Cochran, 1st VP Cathy Boerke, and 2nd VP Christie Goleman met with Senior Services of Central Illinois Executive Director Carol Harms (ML) and other SSCI staff members. To all of our surprise, the most overwhelming issue is the need to eradicate bedbug infestations in senior homes.

As a result of these discussions, the **Blackstock Grant** Committee and the KDO Board of Directors voted to award \$30,000 to Senior Services of Central Illinois to aid in treatment for bedbugs and to assist with conducting a Bed Bug Symposium. This symposium, which offered Continuing Educational Credits, was held on June 13 at the **Dove Conference Center** at **Prairie Heart Institute**. I think we can all agree with **President Kim Cochran** in
